That Victoria's Secret baby is just the tip of a disturbing trend

I've been working in the news business for nearly 10 years, and I can't ever recall a similar string of incidents. Recently, to help keep all these disturbing stories organized on our website we even had to come up with a tag, the macabre, but sadly necessary "toilet births."

So why is this happening all over the place? Good question.

Last month, a prominent Catholic deacon speculated that the rash of such incidents signals the return of the ancient pagan practice of "exposure," in which parents would simply leave their unwanted newborn babies on a rock or in the wild to die.

"It was the Christians who saved [these babies] and transformed those cultures from cultures of death into cultures of life," wrote Deacon Keith Fournier.

However, he said, the rise of the abortion culture seems to be bringing the custom back in an unofficial form, with numerous gruesome stories emerging in recent months of parents unceremoniously discarding their newborn children.

"These contemporary examples substitute a trash can or a dumpster for the rock," Fournier wrote.

But, he said, this trend isn't surprising, since "babies are treated as trash" in abortion clinics across the country.

It's hard to argue with that logic. Take a look at these other recent incidents:

- May 28, 2013 - Report surfaces from China about how Chinese officials forcibly aborted a mother who was 8-months pregnant, literally "yanking" her baby out of her, and then dumping it in the trash can.
- May 14, 2013 - Three former workers at a Texas abortion clinic run by abortionist Douglas Karpen step forward alleging that babies are routinely murdered after being born alive during failed late-term abortions at Karpen's clinic. One of Karpen's former assistants said the abortionist would even "twist" the babies heads off.
- May 13 - Kermit Gosnell is found guilty of murdering three babies born alive during failed abortions by "snipping" their spinal cords. His former employees alleged that "hundreds" of babies were killed in this way. In some cases their dismembered feet were kept in jars, or their bodies stuffed into plastic containers and stored in the clinic freezer.
- May 8, 2013 - Live Action release undercover footage of renowned late-term abortionist Leroy Carhart telling a woman seeking an abortion that after he kills the baby in her womb, it will soften up like "meat in a crock pot," before the body of the baby is removed three days later.
- April 29, 2013 - Live Action releases undercover footage of a worker at a late-term abortion facility telling a woman seeking an abortion to just "flush it" if the baby is accidentally born alive during the abortion. "If it comes out, then it comes out. Flush it...if anything, you know, put it in a bag or something or somewhere and bring it to us," the counselor says.
- April 19, 2013 - A former employee of late-term abortionist Kermit Gosnell testifies in court how on one occasion a fully formed baby was born alive into a toilet. Kareema Cross said the baby was making "swimming motions" as if it was trying to get out. Another of Gosnell's employees, Adrienne Moton, then took the baby out of the toilet, and slit its spinal cord. And this only touches the surface of similarly macabre stories that have come out of the abortion industry. The Gosnell case alone provided hundreds of pages of nausea-inducing stories of living newborn babies crying, squirming and swimming before being brutally murdered and then dumped in the trash can, or ground up in the clinic's garbage disposal. While Gosnell was found guilty because he murdered the babies after they were born, it's clear that his crimes stemmed directly from the abortionist's mentality. In many cases if he had killed the babies minutes earlier, it would have been perfectly legal, or, at worst, a violation of the state's 24-week cut off. To him there was little difference between killing them before or after birth. And is that really all that surprising?

Recently, former Seattle City Council member Judy Nicastro wrote an article in the *New York Times* touting her abortion of her son at 23 weeks, saying that she was "grateful" that the late-term abortion let her son die "in a warm and loving place." In the article she describes, as if it were a beautifully emotional moment, how, "I felt my son's budding life end as a doctor inserted a needle through my belly into his tiny heart."

Pro-life activists tend to believe that if they convince someone that the unborn child is human and alive, then they will be against abortion. But Nicastro had no doubt that that what happened during her abortion was that the abortionist killed her living son. Not a fetus, but her son. And she is "grateful" for that, and thinks it was a beautiful thing, the right thing to do.

So why are there so many stories emerging of moms or others dumping their babies into toilets or trash cans? Could it possibly be the fact that our politicians, our doctors, and our laws, all agree that killing babies and treating them like trash is acceptable, and a critical part of a "free" society? And if so, should we really be surprised when people behave as if that's actually true?

23,000 JOIN NATIONAL MARCH FOR LIFE IN CANADIAN CAPITAL

On a beautiful sunny day in Canada's capital, thousands of pro-life citizens joined the National March for Life to urge Canada's parliamentarians to promote the right to life.

The march this year focused especially on urging Stephen Harper's Conservative government to reject the RU-486 abortion drug, which is currently being considered for approval by Health Canada.

Marchers were surprised to receive a personal message from Pope Francis supporting the event, read during the rally by Cardinal Gerald Lacroix of Quebec City.

The Holy Father "assures [March for Life participants] of his spiritual closeness as they give witness to the God-given dignity, beauty, and value of human life," read the message by Secretary of State Cardinal Pietro Parolin. "He prays that this event foster greater respect for the inviolable right to life of each person from conception to natural death and support the efforts of all who labor to ensure that this fundamental human right receives adequate legal protection."

The march came one day after Liberal leader Justin Trudeau controversially stated that his party would bar pro-life candidates, except sitting MPs, from running in the 2015 federal election.

In his remarks at the rally, Cardinal Thomas Collins of Toronto prayed that all MPs would be free to promote life in accord with their conscience.

"It is the role of all of us as citizens to pray for those who serve us in public office and to pray that each person who is entrusted with the mission of public service would be free to do so with a free conscience," he said. "We pray particularly that all of those who serve us in political life will not in any way feel inhibited from proclaiming the great gift of life, the great gift of marriage."

In his remarks, Cardinal Lacroix noted that there were renovations underway on Parliament Hill, and observed, "Our people can continue to count on us to rebuild our nation, working for the respect of human beings one at a time."

"It's a joy to be here together today once a year but I'm very proud that all year long we continue to help people around us to respect life and we are committed in our own homes, families, parishes, and in our cities and towns, to be lovers of life," he said.

There were twenty-one members of Parliament and senators present at the rally.

By 1:15 the crowd started queuing up to march the streets, with Angelina Steenstra and the "Silent No More" group leading the way. The route this year was longer, enabling all to join in, taking over an hour from start to finish; 23,000 people marching through the city streets takes time and, WOW, it's an awesome sight to behold!

Each year that we come to the March, it is exciting to see familiar faces, but it is even more exciting to see so many new faces, all converging for the same cause. Maybe the most hopeful sign was the significant number of youth, including our own busload full, making up well over 50% of the crowd.

Even though we got caught in a traffic tie-up for an hour and a half on the return trip to Stratford, making us very late and very tired, we were still in good spirits from a day well spent, being counted for Life.

Justin Trudeau: Candidates who oppose abortion are not welcome in Liberal 'open' nomination battles

OTTAWA, May 7, 2014 ([LifeSiteNews.com](http://www.lifesitenews.com)) – Candidates who oppose abortion are barred from running in the Liberal Party's 'open' nominations for the 2015 federal election, Liberal leader Justin Trudeau confirmed Wednesday.

The pro-abortion Catholic said the decision would not affect sitting MPs who are pro-life, but said it was "tough" to answer whether the party would try to force existing pro-life MPs to vote pro-abortion.

The remarks come a mere day before thousands of pro-life Canadians are expected to fill Parliament Hill during the annual National March for Life.

"I have made it clear that future candidates need to be completely understanding that they will be expected to vote pro-choice on any bills," Trudeau said, according to CBC News, after the Liberals' caucus meeting.

"The existing MPs...will be respected to a certain extent in their choices, but our position as a party is we do not reopen that debate," he said.

Cardinal Thomas Collins urges Justin Trudeau to reverse pro-choice rule Liberals' pro-choice candidates rule excludes Catholics, says Toronto archbishop

Cardinal Thomas Collins, Toronto's Roman Catholic archbishop, is urging Justin Trudeau to reverse his decision requiring new Liberal candidates to follow the party's "pro-choice" position.

Cardinal Collins wrote a letter to the Liberal leader on Wednesday saying there are two million members of his archdioceses.

"I encourage all of them, of whatever party, to serve the community not only by voting but by active engagement in political life as candidates. It is not right that they be excluded by any party for being faithful to their conscience," he wrote.

Trudeau announced the party's pro-choice policy on May 7. "I have made it clear that future candidates need to be completely understanding that they will be expected to vote pro-choice on any bills," Trudeau said.

The views of existing Liberal MPs, he said, would be "respected to a certain extent," but the party would not be open to candidates holding anti-abortion views.

The archbishop wrote in his letter that the party line should not trump matters of faith. "Political authority is not limitless: it does not extend to matters of conscience and religious faith. It does not govern all aspects of life." Collins ended his letter with a direct challenge to Trudeau to stand down on his new rule.

"Political leaders in our day should not exclude such people of integrity, no matter how challenging they find their views," he wrote. "I urge you to reconsider your position"

New Democrats file motion to have House of Commons affirm 'woman's right' to abortion

OTTAWA, May 12, 2014 (LifeSiteNews.com) – The New Democrats' critic for the Status of Women tabled a motion last week asking the House of Commons to affirm a “woman’s right to choose abortion” as a “fundamental question of equality and human rights.”

New Democrat MP Niki Ashton filed the motion on Thursday, the same day that about 23,000 marched in the nation’s capital protesting abortion and one day after Liberal leader Justin Trudeau announced that pro-life candidates would be barred from running in the Liberal Party’s ‘open’ nominations.

“The NDP is a pro-choice party,” said Ashton, MP for the riding of Churchill, Manitoba. “Each and every one of my colleagues agrees – women should have the right to make their own decisions in matters of health. Our position is clear and unequivocal, and this is an opportunity for other Parliamentarians to take a stand.”

After Trudeau’s announcement Wednesday, New Democrat leader Thomas Mulcair reiterated his party’s policy that all candidates must support legal abortion, and criticized Trudeau for allowing sitting MPs who are pro-life to run in 2015

PARLIAMENT TO VOTE ON ABORTION

This is a big deal. In spite of the government's insistence not to re-open the abortion debate in Parliament, it looks as though it is now being ushered to the forefront through a motion being tabled by a young outspoken pro-choice NDP MP named Niki Ashton.

Last week Ms. Ashton from Churchill, MB, put forward a motion that "...seeks to have members of Parliament vote on whether access to abortion is a 'fundamental question of equality and human rights, both in Canada and around the world.'

It also calls on the government to make the promotion of gender equity and the support of reproductive health care priorities at May’s international summit on maternal and child health.

The motion also seeks to have the government 'lift its policy of refusing to fund international programs that support a full range of family planning and reproductive health care options including abortion.'"

Our sources at Parliament have told us that there is a chance the motion could be debated prior to the summer recess if it is adopted by the NDP as an official opposition motion.

This motion provides a strong opportunity for Members of Parliament that disagree with Ms. Ashton's position to express their views in the House of Commons. In summary: this motion is "re-opening the abortion debate" on the floor of Parliament in a very tangible way.

All of this means that this is an INCREDIBLE opportunity to share with our leaders how we feel about this important issue. The renewed debate will mean our leaders have a renewed interest in what Canadians have to say on the issue.

In the name of a woman's "right" to choose abortion:

Hundreds of Babies Born Alive After Failed Abortions in Canada, Left to Die

In an "urgent appeal", the ECLJ has called the UN Special Rapporteur on Torture to investigate on children born alive after late abortion, and on methods of late abortion, especially in the United-Kingdom and Canada: [in Canada, between 2000 and 2011, 622 babies born alive after an abortion were left to die.](#)

Some cruel methods of late abortion constitute torture, especially the one called dilatation and evacuation: the foetus, still alive, is dismembered to be pulled out of the womb in pieces.

Appointed by the United Nations Commission on Human Rights, the Special Rapporteur on Torture can examine questions relevant to torture in all countries. He transmits urgent appeals to States, undertakes fact-finding country visits and submits annual reports to the Human Rights Council and the General Assembly.

Scientific evidence proves that fetuses and premature babies can feel pain at least as much as adults. Foetuses are responsive to touch at 8 weeks and have the physical structure to experience pain at 20 weeks.

Amnesty International pressures Mexico to legalize abortion

MEXICO CITY, March 13, 2014 (LifeSiteNews.com) – Amnesty International's most recent *Memorandum* to Mexico's president Enrique Peña recommends the country liberalize abortion laws, as the current constitutions of many of its states are "recognizing the 'right to life of the fetus from conception,'" and are "undermining the enjoyment of women's and girl's sexual and reproductive rights."

The report, titled "Human Rights Challenges Facing Mexico," goes on to recommend that Mexico end the "criminalization of abortion" to ensure "women and girl's access to safe abortion services in cases of rape, incest and where the woman or girl's health is at risk."

The document was issued last month, after Salil Shetty, Secretary General for Amnesty International, visited the country and held meetings with several Mexican authorities, including the president.

Last year, 18 of the 32 Mexican entities reformed their constitutions in order to protect the life of the unborn from conception.

The reforms were later backed-up by Mexico's Supreme Judicial Court, making the new laws "ironclad."

The Mexican Constitution states in its 40th article that states are "free and sovereign," and can therefore have their own laws as long as they do not go against the country's constitution.

KENYAN BISHOPS FEAR TETANUS VACCINE CAMPAIGN IS AIMED TO STERILIZE WOMEN

NAIROBI, Kenya, April 1, 2014 (LifeSiteNews.com) – The Kenya Conference of Catholic Bishops is demanding answers about a national tetanus vaccine campaign that they say is suspiciously like campaigns run in other countries where a birth control agent was covertly mixed in. Run by the World Health Organization and UNICEF, the Kenya campaign exclusively targets Kenyan women of childbearing age (14-49), and excludes boys and men and younger girls who are also at risk from tetanus infection.

The bishops' statement notes that in the Philippines, Nicaragua, and Mexico, the tetanus vaccine was "laced with Beta human chorionic gonadotropin (b-HCG) sub unit ... to vaccinate women against future pregnancy."

When injected as a vaccine to a non-pregnant woman, this Beta HCG sub unit combined with tetanus toxoid develops antibodies against tetanus and HCG so that if a woman's egg becomes fertilized, her own natural HCG will be destroyed rendering her permanently infertile, the bishops explain. In this situation tetanus vaccination has been used as a birth control method.
