The tragic case of baby killer Lucy Letby should wake-up society to the horror of abortion

The medical establishment has been 'playing God' with the lives of innocent babies for decades now. We've grown callous to the lives of tiny children because we have legally killed so many of them.



Lucy Letby is a 33-year-old British nurse and serial killer who was found guilty on August 18 of murdering seven babies and attempting to kill six others at the Countess of Chester hospital between 2015 and 2016.

Letby, the Manchester Crown Court heard, was a calculated killer, injecting infants with air into the blood and stomach, overfeeding them with milk, poisoning them with insulin, and even physically assaulting them. As the children deteriorated, Letby attempted

to convince her colleagues that the babies were dying of natural causes.

As bereaved parents recounted the horrors of watching their children die, the nurse maintained a neutral expression. No matter how emotionally charged the evidence was, she sat passively."

Most have concluded that Letby was obsessed with "playing God" by murdering children while pretending to care for them, later searching the social media profiles of her victims' families to gauge their suffering and grief. She attacked and poisoned the most helpless of victims, and she appeared to take genuine satisfaction in it. It is difficult for the rational mind to understand.

But National Review's profile of Letby, titled "The British Baby Killer," led with an interesting detail: "Lucy Letby's youngest victim was born at just 23 weeks' gestation, which is under the legal abortion limit." That is not insignificant. Judge Goss described Letby's murders as a "cruel, calculated and cynical campaign of child murder" and noted that the babies she killed were "extremely vulnerable" and "fragile." One of those victims could have been legally killed under the U.K.'s abortion laws. Presumably that child would have been equally "vulnerable" and "fragile" in those circumstances – and an abortion at that stage would have been even more barbaric than Letby's horrific methods.

The medical establishment has been "playing God" with the lives of innocent babies for decades now. We've grown callous to the lives of tiny children because we have legally killed so many of them.

So, to those abortion supporters horrified by the spectre of baby-killing by medical professionals: don't turn off the TV. Watch this unfold. Turn up the volume. You helped write this script.

Pro-life hospice president calls legalized assisted suicide in Canada a ‘national horror’

'We have reached the point where we must all protect each other from MAiD,' Delta Hospice Society president Angelina Ireland said.

(LifeSiteNews) – The head of one of Canada’s few pro-life hospice societies warned that euthanasia, since being legalized by the federal government of Prime Minister Justin Trudeau, has become a national “horror” show.

“Unfortunately, there is no reprieve in sight as Medical Assistance in Dying (MAiD) becomes a national horror and the ‘professionals’ sharpen up their needles,” Angelina Ireland, the president of the pro-life Delta Hospice Society (DHS) based in British Columbia, told LifeSiteNews.

Ireland warned that Canada has now reached the point where everyone needs to “protect” each other from those pushing euthanasia.

“We have reached the point where we must all protect each other from MAiD,” she noted.



Recently, Ireland warned about the release of an initiative championed and funded by the Liberal federal government called “Medical Assistance in Dying accredited training program for health professionals.”

She said the training program is nothing more than preparation for “the next phase of the Canadian Cull.”

“They (Trudeau government Minister of Health Mark Holland) want us to think Medical Assistance in Dying (MAiD) is so ‘personal and complex’ that apparently no ordinary person could possibly understand the intricacies of non-culpable homicide,” Ireland said.

The MAiD “training program” was developed by the pro-euthanasia advocacy group Canadian Association of MAiD Assessors and Providers (CAMAP).

In June, prominent pro-life researcher Patricia Maloney called out the Trudeau Liberals for handing out more than \$3 million to CAMAP.

As a result of Canada’s ever-relaxing MAiD laws, the DHS has taken action and has launched “Guardian Angels,” which is a “national volunteer health advocate program that seeks to walk with people on their healthcare journey and support them to find alternatives to euthanasia.”

Ireland said that such programs are needed as Canada has reached the point where we “must all protect each other from MAiD.”

The Liberal federal government under Trudeau legalized euthanasia in 2016, and since that time deaths have skyrocketed under its MAiD program. There has also been a continued push to further expand who can qualify for state-sanctioned death.

The allowance of MAiD for those suffering solely from mental illness came as part of the 2021 passage of Bill C-7, which also allowed the chronically ill — not just the terminally ill — to qualify for doctor-assisted death.

The mental illness expansion was originally set to take effect in March. However, after massive pushback from pro-life groups, conservative politicians, and others, the Liberals delayed the introduction of the full effect of Bill C-7 until 2024 via Bill C-39, which became law on March 9.

In July, LifeSiteNews reported that Ontario has seen deaths by state-sanctioned euthanasia skyrocket by 25% in the first five months of 2023, meaning that the province is on track to see 5,000 die via the grim procedure this year alone.

Greenland women accuse Denmark of inserting IUDs without their consent

Eugenics – contraceptives inserted without consent or informed consent as part of a push to limit or eliminate fertility – continues against women and girls across the developing world.

(LifeSiteNews) — Over the last several years, the reality of neo-colonialism – a top-down push by the elites at the United Nations, the European Union, and in many Western governments to reduce the populations of developing nations

– has come into focus. Nigerian pro-life activist Obianuju Ekeocha has been exposing this agenda through her work, including her essential 2018 book *Target Africa: Ideological Neo-Colonialism in the Twenty-First Century* (you can listen to my interview about the book with her on the link below) and her documentary, *Strings Attached*.

Another chilling example of this neo-colonialism was recently reported by the BBC. Sixty-seven women from Greenland, a Danish colony until 1953 that is now semi-sovereign, are demanding compensation from the Danish government “over a campaign of involuntary birth control.” The campaign consisted of a concentrated attempt to reduce the birth rate among the Indigenous population in Greenland by inserting contraceptive devices into the bodies of women and girls without their consent or knowledge.

The details of this brutal campaign were exposed in a 2022 podcast produced by DR, the Danish broadcaster. A minimum of 4,500 women, some of them teenagers, had Intrauterine Devices (IUDs) put into their bodies between 1966 and 1970. The victims – some of them as young as 13 years old – were not aware that this was being done to them and did not consent to it. The scale of the campaign is staggering: The government of Greenland now “estimates that, by the end of 1969, 35% of women in the territory who could potentially have borne children had been fitted with an IUD.”

This eugenic drive to reduce the population of Indigenous people continued until at least 1975, but “the BBC has learned that it lasted for many years after that.” One woman, when struggling to conceive, discovered in 2009 that an IUD had been inserted into her body. Another woman – who is not named – told the BBC that she “had been injected with a contraceptive in 2014 without her consent.” In response to these revelations, the health minister of Greenland told the BBC that she did not know that “contraception was still being given to women without their consent.” Many medical professionals, in other words, are operating from a eugenic mindset rather than just eugenic policy.

Psychologist Naja Lyberth has now initiated a compensation claim against the Danish government on behalf of 67 women, some of whom are in their 70s and do not want to wait for a joint inquiry of Denmark and Greenland into the forced birth control campaign to complete in May 2025. “We don’t want to wait for the results of the inquiry,” Lyberth told the BBC. “We are getting older. The oldest of us, who had IUDs inserted in the 1960s, were born in the 1940s and are approaching 80. We want to act now. It’s already 100% clear that the government has broken the law by violating our human rights and causing us serious harm.” The 67 women are seeking 300,000 kroner – \$42,150 – each.

That figure seems low considering what the government’s eugenic program took from them. According to Lyberth, in some cases “the devices fitted had been too big for the girls’ bodies, causing serious health complications or even infertility, while in others the women had been unaware of the devices until they were discovered recently by gynaecologists.” The claim has been sent to Prime Minister Mette Frederiksen – Lyberth says that if it is denied or ignored, the next step will be to take the case to court. As the BBC pointed out, this isn’t the first compensation case Denmark has faced from Indigenous people: “Last year, Denmark apologised and paid compensation to six Inuit who were taken from their families in the 1950s as part of an attempt to build a Danish-speaking elite within Greenland.”

That these women should receive compensation is good and just. But it is important to remember that right now, the same practices are being perpetrated against women and girls across the developing world — contraceptives inserted without consent or informed consent; a push to limit or eliminate their fertility. We’ve gotten sneakier about our eugenics campaigns and we use different terminology, but it all amounts to the same thing.

Tens of Thousands of Mothers Sue Makers of Tylenol for Pregnancy Use that Led to Babies Born with Autism

Tens of thousands of mothers are suing the makers of Tylenol in a class-action lawsuit that claims its use during pregnancy led babies to be born with autism.

A study from the NIH found that pregnancy exposure to acetaminophen, the main ingredient in Tylenol, may increase a child's risk for autism and ADHD.

Last October, a federal judicial panel consolidated dozens of these lawsuits alleging that acetaminophen, the active ingredient in Tylenol and generic versions of the drug, can cause autism spectrum disorder and attention deficit hyperactivity disorder.

The main defendant in the lawsuit is Kenvue, which is the former Johnson & Johnson's consumer health unit that is now a "spin-off" of J&J.

Co-defendants in the lawsuit are CVS Health, Rite Aid Corp, Safeway Inc, Target Corp and Walgreens Boots Alliance, which are being charged with failing to warn consumers about the risks of Tylenol.

Kenvue has suffered some setbacks in recent weeks in trying to get some of the lawsuits dismissed, with one of the reasons given to dismiss the lawsuits being that the FDA had approved the product and its labels.

Pregnant women are not the only ones who should immediately STOP using this killer drug. NOBODY should be using it.

Tylenol is a classic example of how corporate profits from the pharmaceutical drug companies are far more important than patient safety, as millions of lives are sacrificed to keep these drugs on the market.

It is also just another example of how the FDA works to protect pharmaceutical companies, and NOT consumers.

Tylenol has been on the market for 75 years bringing in annual revenues that exceed \$300 million.

And the adverse effects from Tylenol have been widely published for over a decade now.

One-Stop Death in Canadian Funeral Home

On May 19, Hugo Pilon-LaRose reported for La Presse that Haut-Richelieu funeral complex in Montérégie, Québec is offering euthanasia (MAiD) as one of its "death services". According to Pilon-LaRose (translated from French):

The death trade, the owner of the Haut-Riche- lieu funeral complex, Mathieu Baker, knows well. [H]e launched a new "turnkey" offer this spring, for approximately \$700, for his clients who are requesting medical assistance in dying and who want to switch from life to death right in the showroom.

Pilon-LaRose suggested that the growth of euthanasia in Québec had led to this new profitable enterprise for the Haut-Richelieu funeral complex.

Since the coming into force of the Act respecting end-of-life care, the number of [MAiD] administered has been constantly increasing in Québec. There were 63 in 2015-2016 and 3663 in 2021-2022. The Commission on End-of-Life Care believes that the removal of the end-of-life criterion from the law in 2020 and the reasonably foreseeable natural death criterion from the Criminal Code in 2021 has accelerated this trend.

[...] In all cases, the body of the deceased is then taken care of by the funeral complex, which has the necessary facilities for the continuation of the journey of the remains until the burial.

Dr. Claude Rivard, general practitioner and expert practitioner of [MAiD] at the Pierre-Boucher hospital in Longueuil, told Pilon-LaRose that he is not surprised by the initiative of the Haut-Richelieu funeral complex.

"[It's] a business opportunity that these people see. In 2021-2022, approximately 5% of deaths occurred through [MAiD]. There is a craze for this end-of-life mode," he says.

Hospitals and nursing homes save money by killing their patients and funeral homes can save money by having clients rent a death room rather than being picked up, thus creating further profit for the funeral home.

Planned Parenthood Sugarcoats the Abortion Pill

Canadian Birth Rate Reaches Lowest in Our History

Statistics Canada released figures in October 2023 that Canada's fertility rate has fallen to 1.33 children per woman. This is the lowest recorded in Canadian history. It revealed that only 351,679 children have been born in Canada in 2022. Although birth rates have been dropping all across the developed world, Canada's drop has been so sharp that Statistics Canada has warned that if it continues, we will soon have the lowest birth rate on earth.

Canada has now joined the countries with the lowest fertility rate, a situation associated with an aging population and increased stress on the labour market, public health and pensions. These countries include Japan, Italy, South Korea and China.

The birth rate fell during the pandemic, but it was expected to pick up afterwards. That hasn't happened because of massive spikes of rent, housing prices and inflation.

An Angus Reid Poll in June 2023 asked women how many children they would like to have had as compared to the actual size of their family. This poll indicated that when women ended their child bearing years, they had fewer children than they would have preferred.

Although the Canadian population is expected to be 50 million by 2043, this will be due almost exclusively to immigration. The latter, however creates problems of its own as it will be difficult to culturally absorb so many immigrants, as well as providing the many social and health care services that will be needed.

REAL Women has repeatedly expressed its concerns about our declining birth rate, to no avail. Nothing has been done. What will it take for a government to come to grips with this problem? The government should have been developing family policies, such as including tax credits or tax deductions and splitting family income for tax purposes rather than taxing couples individually as occurs now. Other countries, such as Hungary, Russia, and China are dealing with the low birthrate problem by implementing a variety of policies. Why then does Canada keep its head in the sand?

MAiDHouse Killed 125 People in 2022

The 2022 MAiDHouse Annual Report reveals that they facilitated 125 euthanasia deaths last year, up significantly from 2021.

MAiDHouse is a euthanasia clinic in Toronto that offers euthanasia for people who do not wish to die by euthanasia in a hospital. In September 2022, Margaret Marsilla ran a petition campaign to prevent the euthanasia death of her 23-year-old son Kiano who was scheduled to die at MAiDHouse on September 28, 2022. In her media release, Margaret wrote:

Dr. Joshua Tepper and Dr. Laurie Morrison ("Dr. Death") have approved the application for medical assistance in dying (MAiD) for my son, set to take place on September 28, 2022, at MAiDHouse. Both the doctors and MAiDHouse, run by Tekla Hendrickson, continue to turn their nose up [at] the requirements of legislation, which was to have built-in safeguards to protect vulnerable individuals.

The MAiDHouse report exposes their plan to expand euthanasia by opening more death clinics. In contrast, the Delta Hospice Society, that provided excellent end-of-life care, was defunded and had its ten-bed hospice building expropriated by the British Columbia government because of their commitment to provide a no-kill hospice.

MAiDHouse exclusively provides euthanasia. MAiDHouse and CAMAP (Canadian Association of MAiD Assessors and Providers) exist to provide and promote euthanasia. Both have been designated as charities by the Canadian government.
