# Argentina's Firebrand President Condemns the Davos Abortion Agenda

Argentine President Javier Milei's speech at the annual World Economic Forum conference in Davos, Switzerland, has gone viral. Milei called out the assembled elites for their drift towards collectivism, socialism, and their commitment to "population control" and "the bloody abortion agenda." In doing so, he spoke for millions.

Milei, who was sworn in on December 10, is a pro-life libertarian who promised during his campaign to consider a plebiscite to repeal Argentina's recent legalization of abortion, which was

opposed by a majority of Argentines. His opposition to both abortion and the LGBT agenda—he eliminated the nation's Women, Gender, and Diversity Ministry within days of being sworn in—has alarmed activists committed to the global advance of a socially liberal agenda.

During his speech, Milei warned:

*A conflict presented by socialists is that of humans against nature, claiming that we human beings damage the planet, which should be protected at all costs, even going as far as advocating population control mechanisms or the bloody abortion agenda. Unfortunately, these harmful ideas have taken a stronghold in our society. Neo-Marxists have managed to co-opt the common sense of the Western world, and this they have achieved by appropriating the media, culture, universities, and international organizations.*

*The latter case is the most serious one probably because these are institutions that have an enormous influence on the political and economic decisions of countries that make up the multilateral organizations. Fortunately, there are more and more of us who are daring to make our voices heard because we are seeing that if we don't truly and decisively fight against these ideas, the only possible fate for us is to have increasing levels of state regulations, socialism, poverty, and less freedom, therefore having worse standards of living.*

Milei even took on feminism in his critique of progressive ideology. "The first of these new battles was the ridiculous and unnatural fight between man and women," he declared. "Libertarianism already provides for the equality of the sexes. The cornerstone of [this] creed says that all humans are created equal, that we all have the same inalienable rights granted by the Creator, including life, freedom, and ownership [of private property]." It was a radical and countercultural statement—the Creator doesn't come up much at Davos these days.

Milei's speech was a direct rebuke to the population control advocates at Davos, referred to by Politico as "The Davos do-gooders." Bill Gates, a longtime backer of abortion groups, called for "global health" spending in developing countries to "get population growth to a steady state" on the opening day of the Forum. Al Gore, who also supports pushing population control measures, told attendees (once again) that radical action was needed to combat climate change; Jane Goodall, a third "do-gooder," concurred. Goodall is also an abortion activist; she publicly condemned the overturn of *Roe v. Wade*, stating that abortion is essential to the "protection of ... the environment."

# The Lethal Legacy of the Supreme Court Decision January 28th 1988 re Abortion

I still remember where I was when I received the call that the justices of the Supreme Court of Canada had struck down Canada's abortion law. That message stopped the baking, the family chatter, and me in my tracks. I could not believe the Supreme Court would abandon Canada's little ones and their mothers. Even though the 1969 abortion law was abysmal it still held that killing a child through abortion was a matter of Criminal Law and included guidelines.

The 1969 law was the beginning of Canada's abandonment with the expansion of our abortion provisions, finally completely severing all legal protection of children's lives in the womb, in 1988, with the Supreme Court decision in the Morgentaler case. It has been said that even with our valiant attempts pro-lifers have not been able to engage the whole of this country in this debate. That, I suppose is true. However, this debate is not only about engagement - winning or losing, but about the killing of 4,500,000 Canadian children by abortion, the lack of legal protection of their lives and the fall-out on their parents and Canadian society since 1969.

Canada's medical associations seem content to confirm the belief in the public eye that children before birth are a part of their mothers, like a toe or a fingernail and that killing patients or assisting their suicide are ethical end of life options! Rather than doing no harm, this moral and ethical cowardice, places women, their offspring, the vulnerable sick, elderly and dying into the arms of physicians who will kill.

**What the member groups of Alliance for Life Ontario have done is constantly and consistently raised our voices against the slaughter. Together, our efforts have and will continue to prick the conscience of this great nation, be a thorn in the side of her politicians, and a gauntlet of challenge to the medical profession, pro-abortion and pro-euthanasia/assisted suicide advocates.**

Physicians who refuse to engage in being killer doctors are ridiculed, threatened by their associations and government, forced to choose between their beloved profession or killing. These are strong words but what do we call it when the government says killing is care and professional associations develop guidelines which add killing into your workplace?

Our voice has been there from the start expressed by the wonderful people from Hamilton, Burlington, London, Ottawa and Toronto who presented to the House and Welfare Committee during 1967 and 1968. Displayed in the petition and letter writing campaigns that have been nonstop over the years. Our concern has been voiced within the hundreds of briefs written and presented at all government levels over the years.

We have been active in the many pregnancy support services and homes that have been developed across Canada. Our challenge has been carried in the media campaigns that are aired all across the country and most noticeable in the annual pro-life marches which occur at provincial and national levels.

Our voice is nowhere more present than in the hearts of those who volunteer and work for pro-life groups from one end of this country to another day in and day out. The presidents and boards their staff and volunteers all committed to changing our culture to one in which children before birth are protected by law and women unexpectedly pregnant fully supported never having to resort to killing their children. A time when men will act like men and support their children not abandon their mothers. A time when families will act like families and care more deeply for their vulnerable members.

A time when governments will provide life giving support to all Canadians not legalize ways and means of killing. A time when physicians will stand strongly and proudly against the whims of Canadian governments and society and practice medicine that is life and hope sustaining

This country has travelled so far – the wrong way. Fragile lives at every stage are forfeit, because they are unwanted, face challenges, or are sick and dying. Canada's current answer to all these situations is to kill - but the words used protect the public from the understanding truth of the horror unfolding.

We terminate pregnancy – not kill the child in the womb. We conduct pre-natal genetic testing and terminate the pregnancy – not lethally discriminate against those who are so vulnerable. We induce labour, cutting short to the little lives with genetic anomalies, some we just neglect until they die. We create human beings, quality control them, discard them, freeze them and conduct lethal research on the tiniest of us and call it assisted reproductive technology. Did you know that Canada allows the creation of a human being just for the purposes of practicing or training In Vitro techniques?

We have a double standard in Canada currently. Canadians facing terminal illness or struggling with symptoms from disease, illness or disability are legally allowed to ask a physician to kill them or help them to commit suicide.

The public hear "medical aid in dying" or medically assisted death" and other such euphemisms but it is euthanasia and suicide in reality. When did killing the vulnerable become a Canadian value? If a physician suggested that they kill me now or that they would assist me to kill myself, punishment would currently ensue. However, asking me that same question at my most vulnerable time, of sickness, disability or dying is somehow good!

# Parks Canada permits euthanasia (MAiD) on its premises

Many people have reacted with shock to the story that Parks Canada is permitting euthanasia on their premises.

Everything to do with euthanasia (killing people by poison upon request) is dangerous, socially lethal and wrong, but the news story about Parks Canada was disappointing but not surprising.

In May 2023 I wrote an article titled: *One stop death in Canadian funeral homes: a business opportunity*, concerning a Québec funeral home that was offering euthanasia on its premises.

A CBC news article published on October 26, 2021 reported that the Northview Funeral Chapel in London, Ontario began offering MAiD rooms in early 2020. In March 2022 Churchill Park United Church in Winnipeg Manitoba hosted the euthanasia death of Betty Sanguin (86). Sanguin, who was living with Amyotrophic Lateral Sclerosis (ALS) died by lethal injection in the sanctuary of the Church.

There have been reports of euthanasia deaths in many locations. It is disappointing but not surprising that Parks Canada is allowing euthanasia on its premises.

## The assisted suicide lobby pass "restrictive" assisted suicide bills and expand them later.

One of the key strategies of the assisted suicide lobby is to present an "restrictive" assisted suicide bill for the purpose of getting it passed and once it is passed they introduce bills in subsequent years to expand the assisted suicide legislation.

This is not a new strategy. What has changed is that the assisted suicide lobby is publicly admitting their **"bait and switch"** tactic.

For instance, Josh Elliott has been sponsoring bills for years to allow terminally ill people to take their lives (aka "aid in dying"). The version he plans to resubmit this year has been narrowed to cover terminally ill people with prognoses of less than six months to live, with sign-offs from two doctors and a mental health professional, monthly check-ins, and at least a year of state residence.

"Almost no one" would qualify under that restricted version of the law, Elliott said. But passing it would open the door to evaluation and expansion.

Clearly the assisted suicide lobby are willing to admit to their 'bait and switch' tactic.

The key to holding the line on assisted suicide is to stop legalizing it. The key to defeating an assisted suicide bill is to call it what it is. The purpose of assisted suicide is to cause death.

The other key to defeating assisted suicide bills is to clearly explain what the assisted suicide bill says.

We now have solid evidence that when an assisted suicide bill is "restrictive" that the intention is to pass the bill and expand it later.

The assisted suicide lobby will use false terminology to sell assisted suicide as a form of healthcare that provides "choice" at the end-of-life. Assisted suicide is not healthcare or aid in dying and it provides death at the end of life.

# Elon Musk says ‘the unborn have no voice’ in response to Jane Goodall’s pro-population control video

(LifeSiteNews) — Elon Musk has said that “the unborn have no voice” in response to a video from World Economic Forum (WEF) contributor and population control advocate Jane Goodall.

“She is so wrong,” Musk wrote on X, formerly Twitter. “Arguing in favor [of] reducing humanity is arguing for genocide. The unborn have no voice.”

Musk’s comments came in response to a video clip from an older interview posted by “Wide Awake Media,” in which Goodall advocates for reducing the human population.

“If I were allowed to change a few things, if I had this magic power, I would like to, without causing any pain or suffering, reduce the number of people on the planet because there’s too many of us,” Goodall stated. “It’s a planet of finite resources, and we’re using them up.”

In a recent interview with Joe Rogan, Musk blasted the far-left environmental movement that seeks to drastically reduce the number of people on the planet as a “death cult” that has a “corrosive effect on civilization.”

Musk also correctly diagnosed abortion as one of the critical problems that lead to declining birth rates without explicitly condemning the killing of the unborn.

In response to Ohio’s radical abortion amendment passed in November, Musk wrote on X that “Women in the West have been taught that an accidental pregnancy is the worst thing that could possibly happen to them.”

“Thus, they strongly oppose abortion bans as being an existential threat,” he continued. “Many men also fear that they will be unable to have ‘fun’ if abortion is outlawed.”

Musk’s recent statements seem to imply that he generally opposes abortion; however, Tesla, one of his companies, reportedly has an abortion fund to help employees kill their preborn babies.

# Suicide Machine Will Ask Three Questions Before it Kills Them

The inventor of the suicide capsule has revealed that the device's software will ask three questions of the user before it turns on the power so that the user can press the button to end their own life.

Dr Philip Nitschke, founder of the suicide advocacy group Exit International, originally introduced the device, which he calls the "Sarco machine", in 2019. In an interview with SWI swissinfo.ch given in 2021, Nitschke said "It's a 3-D printed capsule,

activated from the inside by the person intending to die. The machine can be towed anywhere for the death".

"The person will get into the capsule and lie down ... They will be asked a number of questions and when they have answered, they may press the button inside the capsule activating the mechanism in their own time".

Describing the actual manner of death, Nitschke said "The capsule is sitting on a piece of equipment that will flood the interior with nitrogen, rapidly reducing the oxygen level to 1 per cent from 21 per cent in about 30 seconds. The person will feel a little disoriented and may feel slightly euphoric before they lose consciousness. Death takes place through hypoxia and hypocapnia, oxygen and carbon dioxide deprivation, respectively".

The machine is intended to remove the need for doctors' involvement

In 2021, Nitschke said "Currently a doctor or doctors need to be involved to prescribe the sodium pentobarbital and to confirm the person's mental capacity. We want to remove any kind of psychiatric review from the process and allow the individual to control the method themselves".

He added "Our aim is to develop an artificial intelligence screening system to establish the person's mental capacity. Naturally there is a lot of scepticism, especially on the part of psychiatrists. But our original conceptual idea is that the person would do an online test and receive a code to access the Sarco".

Under the frequently asked questions on Exit International's official page on the Sarco pod, the organisation claims that safeguards are in place against misuse, specifying that "The detailed technical specifications and plans will only be available to subscribers to The Peaceful Pill eHandbook. This book is restricted to people [older than] 50 years & of sound mind". Assisted suicide does not always go according to plan

While Nitschke suggests that death would take 5-10 minutes, physicians from countries that have already made assisted suicide and euthanasia legal tell a different story. Dr Brick Lantz, orthopaedic surgeon and state director of the American Academy of Medical Ethics, emphasised that it is not uncommon for an assisted suicide to go wrong.

"The failures are brutal when someone fails assisted suicide and the failures are not infrequent. In fact, there was one that woke up from a coma after multiple days. There was a nurse at the bedside of one who ended up putting a plastic bag over the patient to kill the patient because they weren't dying", he said.

Dr Lantz also pointed out that the safeguards in Oregon that are intended to protect the vulnerable do not work. "The safeguards in Oregon are not being followed. That includes the psychiatric referral, second opinion and the 6 month time estimate for death", he said.

Spokesperson for Right To Life UK, Catherine Robinson, said "Dr Nitschke's suicide machine is not only a clearly horrendous concept, but it is becoming increasingly clear how few realistic safeguards are in place for those who might attempt to use the device in future. This apparently fully automated process is a disaster in waiting. Relying on an online test to establish whether a person is of "sound mind" is already open to abuse. To then rely on a machine-based final assessment of the individual's identity and awareness of their actions once again removes the decision making from any human authority with the patient's best interests in mind".
