Palliative Care or Something Else?

Dear RHSP Board, RHSP Executive Director, SRC Executive Members and Area Members of Provincial and Federal Governments:

From the 1977 Reader's Digest Great Encyclopedic Dictionary & 1973 Funk & Wagnalls Standard College Dictionary:

Palliative - *adj. tending to palliate 2. to relieve the symptoms or effects of a disease without curing,*

Care - *n. 3. watchful regard or attention, heed*

I worked in a long term care facility - Freeport Hospital from 1982-1998 eleven of those years as a front line nurse's aide or orderly on chronic and palliative care units. I enjoyed it very much and came away with a deep respect for nursing care, limitations and purpose. From it I learned that we, as care givers, are not GOD... and are charged

with 'doing NO HARM', working within the medical, surgical, nutritional, pharmaceutical and rehabilitation capabilities of those professions to help patients recover, mend, and rehabilitate OR to make comfortable, viable and meaningful a progressive condition that will bring about the end of LIFE. Never in my experience then, or since, having left healthcare, have I ever been exposed to sound medical teaching that did NOT celebrate and encourage LIFE to be lived to its intended limit (left in the hands of the LIFE GIVER...GOD). We receive life from the Creator of LIFE, not from anything we do, cause or have been able to invent.... LIFE IS A GIFT FROM GOD.

Our universities and our governments, both federal and provincial, are attempting to change things.

Medical and nursing schools are now lead by those with left ideologies who have little respect for LIFE.

Federally, the politicians and lawyers are trying to redefine what healthcare is, what lives matter, and who decides if your life matters.

Provincially, end of life healthcare is not funded (evidenced by the closure of many chronic care hospitals and the creation of 'private' hospices) yet these same provincial ministries of health seem to feel it is within their powers of administration to dictate to the private hospices policies for types of "care" they MUST provide regardless of the philosophy of those private care hospices, ie. what each must do to be allowed to operate, function, be granted permission to care for end of life patients (even though they have nothing to do with funding).

The definition of Palliative Care has not changed, regardless of what the Fed's define as LEGAL and the provincials define healthcare IS. It is still making patients comfortable, appreciated and yes, LOVED, for as long as GOD gives them breath and LIFE! You can argue regarding extending one's life artificially such as assistance by machines to allow breathing, cardiac resuscitation etc. for extended periods of time ... BUT ending another human's life by poisoning, starving, over medicating, or depriving of basic care needs is nothing short of murder, not healthcare.

Wrapping the procedure in names like MAiD or doctor assisted death or others DOES NOT CHANGE WHAT YOU ARE DOING. You are killing them.

Ontario woman asked to donate husband's organs after he was denied transplant for being unvaccinated

35-year-old Garnet Harper died after hospitals refused to perform a life-saving kidney transplant on him because he did not take the experimental COVID-19 shots.

SUDBURY, Ontario (LifeSiteNews) — Canadian health officials asked an Ontario woman to donate organs of her husband who died after being denied an organ transplant because he did not receive the COVID-19 shots.

In May, Trillium Gift of Life Network (TGLN), the Ontario organ donation agency, called Meghan Harper to harvest her husband Garnet's organs as he lay dying because the hospital refused to provide organ transplants to unvaccinated Canadians.

"They call you while you're sitting next to your dying loved one and they ask you if they can have his organs," Megan told independent journalist Monique Leal.

"Meanwhile, he wasn't good enough to receive organs

from them... I can't describe the feeling," she continued. "It makes me sick to my stomach."

According to Meghan, the TGLN associate was unaware that Garnet was dying because the hospital refused to perform a kidney transplant on an unvaccinated Canadian.

"She was surprised, and obviously had no idea," Megan recalled.

"I tried to offer her some education about what is going on in our country," she continued. "I told her that things need to change, and by the end of the call, she agreed with me. She said, 'I had no idea' and she would pass her comments on to her higher-ups."

In February 2022, Garnet was diagnosed with stage five kidney disease. Two of Garnet's brothers offered to donate their kidneys, but the hospital refused to consider them as Garnet would not disclose his vaccination status.

Canada's current public healthcare policy denies organ transplants to those who have not received at least two doses of the experimental COVID vaccine.

As a result, on May 22, 2023, 35-year-old Garnet died of a bleeding stroke during his sleep, leaving behind his wife and five children.

Harper was not alone in his battle for medical care as a COVID-unvaccinated Canadian. Alberta resident Sheila Annette Lewis was also denied an organ transplant because she refused to take the COVID shots. She has now been approved for the procedure at a hospital in the United States but will need to pay for the medical care.

Following his death, Canadian freedom fighters are rallying Canadians to make their voices heard by refusing to donate organs until the unjabbed are treated equally.

On July 24, pro-freedom Christian pastor Henry Hildebrand appealed to Canadians to fight back against the current Canadian medical system.

"Are you an organ donor in Canada?" Hildebrandt asked. "I believe it's time to put that on hold until our government stops fatally discriminating against its citizens."

"My heart goes out to the family of the late Garnet Harper and to Sheila Lewis who is still struggling to get care," the pastor stated.

Similarly, last week, former Ontario MPP Randy Hillier condemned the Canadian medical system, tweeting, "Only the tip of the iceberg is ever seen before the real tragedy befalls. Our governments are and have been engaged in social murder."

"Unfortunately, many people believe recognizing these facts and speaking out is more dangerous than becoming the inevitable next victim," he added

‘Sound of Freedom’ overcomes media opposition to a staggering \$40 million opening week

Mon Jul 10, 2023 (LifeSiteNews) — Despite relentless, desperate attempts by secular media to prevent the public from seeing *Sound of Freedom*, the movie has already earned more than \$40 million in ticket sales – nearly three times its cost to produce – and is projected to finish out the weekend in third place.

The movie is based upon the true story of former government agent Tim Ballard who quit his job to rescue a little girl from sex traffickers in the Colombian jungle. In the process, Tim ended up saving 123 people, 55 of whom were children, from one mission alone.

Since then, Ballard and his organization, Operation Underground Railroad, have rescued thousands of children.

In what appears to be a panicked reaction to the film’s success, secular media has done everything in its power to keep the public from seeing it. Both *The Guardian* and *The Washington Post* attempted to taint the movie by suggesting a link to the QAnon movement.

CNN likewise aired a QAnon-based review of the movie in a desperate attempt to ward people away from educating themselves concerning the horrific child sex-trafficking industry.

Attempts by mainstream news outlets to undermine the movie have been powerless to overcome the strong grassroots word of mouth recommendations in communities across the nation.

Ontario projected to see 5,000 euthanasia deaths in 2023 alone

Wed Jul 12, 2023 (LifeSiteNews) — The Canadian province of Ontario has seen deaths by state-sanctioned euthanasia skyrocket by 25 percent in the first five months of 2023, meaning the province is on track to see a whopping 5,000 die via the grim procedure this year alone.

According to up-to-date information posted online by the Euthanasia Prevention Coalition (EPC), Ontario saw some 1,866 deaths by medical assistance in dying (MAiD) from January to May 2023. By comparison, in the first five months of 2022, 1,488 people died by MAiD.

Due to the 2023 numbers showing an increase of around 25 percent compared with the record numbers set in 2022, it is estimated by the EPC that Ontario will see as many as 5,000 deaths from MAiD come the end of the year.

Last week, LifeSiteNews reported on recently released records obtained by a pro-life researcher through a Freedom of Information request that show that Ontario’s health ministry allowed procedures for euthanasia to be billed under codes for “palliative care,” meaning the true taxpayer cost for the deadly procedure is likely higher than previously thought.

In late June, LifeSiteNews also reported about the case of 33-year-old quadriplegic Rose Finlay of Bowmanville, Ontario. Finlay, who is a mother of three, said it was easier for her to get approved for state-sanctioned euthanasia than it was for her to successfully obtain help for the disabilities she has been suffering with for years.

According to the EPC, 13,500 Canadians died by MAiD in 2022, with the province of Québec having the highest number of deaths not just in Canada, but in the world.

Last month, LifeSiteNews reported about how pro-life researcher and blogger Patricia Maloney laid bare how the Liberal government of Prime Minister Justin Trudeau has handed out more than \$3 million to a pro-euthanasia advocacy group, the Canadian Association of MAiD Assessors and Providers.

The Trudeau government legalized euthanasia in 2016, and since that time deaths have skyrocketed under the MAiD program. There has been a continued push to further expand who can qualify for state-sanctioned death.

The expansion to include MAiD to those suffering solely from mental illness came as part of the 2021 passage of Bill C-7, which also allowed the chronically ill – not just the terminally ill – to qualify for doctor-assisted death.

The mental illness expansion was originally set to take effect in March of this year. However, after massive pushback from pro-life groups, conservative politicians and others, the Liberals under Trudeau delayed the introduction of the full effect of Bill C-7 until 2024 via Bill C-39, which became law on March 9.

‘Pride’ marchers chanting ‘we’re coming for your children’ shows what the LGBT agenda is about

The pedophilic words chanted by a corps of New York drag queens were as vivid a wake-up call as can be imagined.

Tue Jul 4, 2023 (Fr. Michael P. Orsi) — If you’ve taken comfort in the notion that today’s gender movement is just a bunch of harmless, confused people struggling with their personal conflicts and longing to express their true sexual identities, this year’s Pride Month surely has challenged all your assumptions.

The parade that capped off June’s Pride events in New York City proclaimed the movement’s actual intentions quite clearly. The message was chanted all along the route, repeatedly and at high volume:

“We’re here, we’re queer, we’re coming for your children.”

Now, there’s a sentiment that should make your blood run cold. It gives the lie to all those innocent protestations you’ve heard for years: “Gee, all we want is to live our lives and love who we love.”

It’s well past time to wake up and recognize the truth. We are living in a very dangerous time filled with threats to our physical and mental health, and to our immortal souls.

The pedophilic words chanted by a corps of New York drag queens were as vivid a wake-up call as can be imagined. This was perversion on proud display. It was an assault on childhood innocence, on family life, on decency, on religion, on basic human reality. It was as vivid and unignorable as a declaration of war.

The time for kindness and tolerance has passed. These people must be opposed on every level in every way.

The problem, of course, is that the gender movement has secured alliances among the leadership of government, business, finance, media, the arts — virtually every institution of society. The country has been severely compromised by this pervasive and insidious gender ideology.

Perhaps most thoroughly compromised is the school system. Public elementary and secondary education has been remade by at least two generations of politicized teachers, trained in colleges and universities that are imbued with progressive thinking, and committed to indoctrinating schoolchildren to become agents of social change.

Not only are public schools ideologically distorted, they are the places where profound influence is exerted on kids for up to eight hours a day, five days a week (plus time spent in extracurricular activities).

For all that, however, education is the one area in which mothers and fathers can exercise effective resistance. They have the ultimate option of removing their children from public schools. Especially Catholic parents.

Demographic changes also came into play. Catholic families were leaving the great urban ethnic enclaves. They moved to the suburbs, where rapidly growing school districts offered shiny new buildings, and it seemed like sending the kids to public school was the route to full social acceptance and success.

Parochial education declined accordingly, and the effect has been felt keenly in the Faith. Mass attendance has fallen from 78 percent of Catholics in the early ‘60s to 30 percent today. In some areas it’s even less, and society at large is suffering, as a consequence.

School-choice financing systems are gaining ground. In several states, such as my own state of Florida, public education funds can be used to cover private-school tuition and related expenses.

This is all very encouraging. But we need more. Much more.

The devil wants us to give up. He wants us to watch the moral disaster unfolding around us in our country, and to assume that decline is inevitable.

And he’s meeting with a good deal of success. Many people have concluded that there’s nothing to be done about the great wave of perversion that’s come upon us. Unfortunately, even some churches have drawn that conclusion. Disputes over how to address gender conflict are tearing many congregations apart, in some cases whole denominations.

This spring, as I watched our First Communion class, I was struck by the sight of those innocent and vulnerable children receiving Our Lord for the first time. I was charmed.

But then I was disturbed by the thought that those first communicants whose education is in public schools are unlikely to ever hear anything that helps them grow in their faith. On the contrary, they may very well encounter the evil that was on display in that notorious Pride parade.

And those terrible words rang in my ears: “We’re here, we’re queer, we’re coming for your children.”

Moral Law never changes. St. John Paul II wrote, in the Gospel of Life:

The sacredness of life gives rise to its inviolability, written from the beginning in man's heart, in his conscience. The question: "What have you done?" (Gen 4:10), which God addresses to Cain after he has killed his brother Abel, interprets the experience of every person: in the depths of his conscience, man is always reminded of the inviolability of life - his own life and that of others – as something which does not belong to him, because it is the property and gift of God the Creator and Father. The commandment regarding the inviolability of human life reverberates at the heart of the "ten words" in the covenant of Sinai (cf. Ex34:28). In the first place that commandment prohibits murder: "Thou shalt not kill" (Ex20:13); do not slay the innocent and righteous (Ex23:7).....But the overall message, which the New Testament will bring to perfection, is a forceful appeal for respect for the inviolability of physical life and the integrity of the person. It culminates in the positive commandment which obliges us to be responsible for our neighbour as for ourselves: "Thou shalt love thy neighbour as thyself."

In our post-Christian era, respect for the sacredness of life seems to have all but disappeared. Under the guise of human rights, the deliberate killing of innocent human beings, from pre-birth to elderly and beyond, has been enshrined into law. And it continues to expand the parameters for this murder (which also includes murder of the spirit). It has continued so far that children are being treated like possessions; being kidnapped, bought and sold. And they are being used and abused as sex slaves. This has, and is, being uncovered and exposed by some brave, faithful people. The movie "Sound of Freedom" dramatizes the efforts of Tim Ballard, a real life hero (and a dad). He saved a young boy who was being trafficked, who convinced him to rescue his sister; then Tim convinced the local authorities to

help rescue a very large group of trafficked children and imprison their captors. This film has brought to light the plight of millions of children who have been kidnapped for abuse. This evil is real; it is so widespread that these people, many in powerful positions, are working to dissuade the public from seeing it; a credible film which exposes them. So, when we hear that someone is coming for our children, take them seriously, because this has been happening for quite some time, and they have gotten away with it. Purveyors of Evil cannot stand the Light. They prey upon the innocent and the weak. There are things going on behind closed doors and in the dark that they do not want any of us to see. It is up to us to shine a Light so that there is nowhere for them to hide their "dirty deeds".

Keep your eyes open, educate yourself with Truth, and get involved. Work for the good, as though everything depends upon you, and then pray to Almighty God as if everything depends upon Him.
