America's Reproductive Assault Weapons

The Incredible Shrinking Woman was a 1981 movie about a housewife who grows smaller after being exposed to chemicals found in household products and cosmetics. It was a fictional comedy, but what is happening today as women ingest a different type of chemical is not fiction, and it is certainly not humorous. In truth, it is a panoply of drugs, devices, and surgeries scooped up by women who have bought the reproductive rights lie.

Countering this ongoing destructive campaign are people who do their level best every day to help women and care for them in their time of need in places known as pregnancy help centers, and while their work is honorable, their public image is often quite the opposite. This is why Congressman Chris Smith has introduced the Pregnancy Center Support Act—a proposed law that would implement a 50% tax credit for anyone who chooses to financially support these centers.

The facts about contraception, its dangers, and its various mechanisms of action—including aborting young embryos—are not on the table when politicians ply their trade in public. Very few are willing to expose the hazards, especially since the majority of Americans, ignorant of the facts, support their use. In fact, medical journals use words such as could or might when discussing the interference the pill has with implantation.

But, as we well know regarding basic fetal development, if the human embryo does not implant, she dies.

In addition, the most effective chemical assault weapons females use to ensure the death of their preborn children are called medication abortions. By ingesting pills such as mifepristone and misoprostol, a mother can kill her preborn baby as far along as 70 days gestational age.

Keeping this in mind, we suggest that when politicians say they are taking steps to protect a "right" to contraceptive "care," they are really telling the public they favor chemical assault weapons that kill the preborn. But neither elected officials nor those who vote for them seem to be concerned enough to seek the truth. Nor would such people approve of our description of the most favored forms of fertility control as weapons of mass destruction, even though that is what they are.

If we were living in a morally sound country, the people of this nation would be up in arms over such facts. Indeed, I dare say we might actually achieve a total ban on such pills and devices, not to mention surgical abortion. But we do not reside in such a place.

After more than half a century of decriminalized availability of such lethal tools, some would say we are fighting an unwinnable battle. But such opinions are based on human factors, not on the Truth as Christ has taught us, including the fact that "for God all things are possible."

We are on a battlefield, engaged in a deadly war, yet our hope never wanes. We trust in the mercy of God, the truth of our words, and the integrity of the human person. Our enemies are bloodthirsty, yes, but we have the armor of God, and we know that He is always with us.

At first you think, 'well it is aimed at dying children,' until you realize it was uploaded to Youtube, Vimeo, Facebook, Bitchute, and other platforms and is listed as "satire," in some of the video descriptions. Then we find out that it is being shown as an advertisement within other videos.

So all children allowed to visit video platforms are being exposed to this.

YouTube eventually deleted the actual video for "violating Youtube's Community Guidelines," but we are unable to ascertain whether the advertising within other videos has also been disabled. It was uploaded to Bitchute by a user, with the statement "This is clearly yet another facet of the multi pronged attack against us, with our children being used as an attack vector."

The #satire" label has people wondering if this was "dark humor" taken too far, but the pace this has become viral indicates that someone has worked hard to make sure this is seen by as many people, including children, as possible, and available on as many platforms as possible.

Trudeau praises ‘universal access to contraceptives,’ slammed by pro-lifers

OTTAWA, Ontario (LifeSiteNews) — Canada’s top pro-life group has blasted Prime Minister Justin Trudeau for promoting the “killing of newly conceived babies” after the leader praised new legislation seeking “universal access to contraceptives” including the “morning after pill.”

“Universal access to contraceptives. Here’s what that will mean for women across Canada: No more having to pay out-of-pocket for your reproductive health care. And yes, that includes the morning after pill — because when we say we support reproductive rights, we mean it,” posted the pro-abortion Trudeau on X, formerly Twitter, today.

Trudeau’s remarks concern Bill C-64, also known as “An Act respecting pharmacare,” which aims to create a national pharmacare program, despite healthcare in Canada falling exclusively under provincial authority. The bill was introduced on February 29 in the House of Commons.

His new pharmacare legislation came about under a demand from the New Democratic Party (NDP) and its leader Jagmeet Singh. The NDP leader said his support for the Trudeau government, which is keeping the Liberals in power, would crumble unless the prime minister introduced pharmacare legislation before March.

Trudeau’s X post was immediately condemned by Campaign Life Coalition’s Director of Communications Pete Baklinski, who said the so-called morning-after pill, which “kill newly conceived babies,” should be “banned” in Canada.

“As if it’s not bad enough that the Liberals are trying to contracept Canada out of existence with their terrible pharmacare plan, now they’re also going to cover pills that kill newly conceived babies,” wrote Baklinski in reply to Trudeau’s post.

“That’s right. The morning after pill, or Plan B, can be abortifacient to the newly conceived embryo. Plan B can be a killer pill. It should not be promoted in Canada; it should be banned. Shame on this government for always getting it wrong when it comes to life issues.”

Other Canadians also took to the post to rebuke the prime minister over his anti-life agenda.

While the new legislation is troubling, it is not a stark departure from the already bleak status quo, as it only seeks to provide a framework for funding to provinces to cover certain diabetes drugs and contraceptives. All provinces, however, already have in place similar plans that cover most drugs. Some provinces, such as Alberta and Quebec, have nonetheless said they will be opting out of the program.

Bioethics group admits most people declared ‘brain dead’ actually have brain function

(LifeSiteNews) — On April 11, 2024, the National Catholic Bioethics Center (NCBC) issued a landmark position statement, acknowledging that at least half of patients diagnosed as “brain dead” still have partial brain function. The NCBC statement was prompted by the 2023 updated guideline for the diagnosis of “brain death” published by the American Academy of Neurology (AAN) together with the American Academy of Pediatrics, the Child Neurology Society, and the Society of Critical Care Medicine.

According to the NCBC, the 2023 AAN updated guideline marks “a decisive breakdown in a shared understanding of brain death” and “a formal breach in a longstanding consensus in law and public policy” because this guideline does not conform to the current legal standard for “brain death” under the Uniform Determination of Death Act (UDDA). The UDDA requires the “irreversible cessation of all functions of the entire brain, including the brain stem.” But a part of the brain called the hypothalamus continues to provide neuroendocrine function in most patients declared “brain dead.” Is the hypothalamus important? According to the NCBC:

The hypothalamus can be understood as a kind of ‘smart’ coordinating center in the brain which is involved in regulating temperature, salt-water balance, sex drive, and sleep. Recent studies show that it may play a role in phenomenal awareness and pain detection.

In particular, the NCBC criticized the 2023 AAN “brain death” guideline for instructing “that clinicians may declare patients brain dead despite evidence of neuroendocrine function.” Because of this, the NCBC states:

Hypothalamic functioning shows that not all functions of the entire brain have ceased, as stipulated by the UDDA. Consequently, patients with confirmed hypothalamic function should not be diagnosed as brain dead, nor treated as dead, for the purpose of organ procurement.

The NCBC statement cited recent studies pointing out that neuroendocrine function (i.e., hypothalamic function) continues in 50-84% of patients diagnosed as “brain dead.” But it has long been known (at least since 1993) that the hypothalamus continues to function in “brain dead” patients. Every “brain death” guideline issued by the American Academy of Neurology (in 1995, 2010, and 2023) has stressed that “brain death” is a clinical diagnosis that requires only a bedside neurological examination. And even the 1995 guideline specifically mentions that “brain death” may be declared despite normal blood pressure and urine output, both of which are evidence of hypothalamic function. This is the same as saying (as per the 2023 AAN guideline) that clinicians may declare patients “brain dead” “despite evidence of neuroendocrine function.”

The current leadership of the NCBC deserves credit for this stunning admission given that, after decades of being a staunch supporter of “brain death,” the NCBC now acknowledges that half or more of “brain dead” patients still have brain function. For years, doctors have been dissecting still-living people to death for the sake of their organs!

However, the NCBC statement doesn’t go far enough because it continues to determine life or death on the basis of function: the function of the hypothalamus. Our humanness is not based upon our abilities or functions, but rather upon what we are. Every human person is a body-soul unity made in the image of God.

Christianity, Judaism, Islam, and most other religious traditions define death as the separation of the God-given spirit (or soul) from the human body.

A respect for the sanctity of human life demands that we be absolutely sure that the soul has departed before pronouncing a person dead. Because the soul is immaterial, we do not have any human device to determine the exact moment of death when the soul departs. Therefore, as a safeguard against declaring death prematurely, the loss of heartbeat, breathing, and the passage of time have been used for millennia to be sure that the spirit has departed.

This recent admission by the NCBC shows that the public has been misled about “brain death” for too long. It is wrong and inhuman to label people as “brain dead” and treat them as commodities. Everyone who has lost a loved one to organ harvesting should be outraged. Registered organ donors should revoke their donor status, and everyone should carry a refusal to donate card. Every state should pass legislation allowing people to opt out of a “brain death” determination for any reason. “Brain death” is not death, but a legal fiction, a way of removing civil rights from vulnerable, brain-injured people for the sake of their valuable, viable organs.

How a handful of billionaires created the transgender "movement"

An interview with Jennifer Bilek

Bilek is an artist, activist, and investigative journalist based out of New York City, and her work has been published in Tablet Magazine, The Federalist, The Post Millennial, and elsewhere. Bilek spent her life on the Left, but now she says that she is in the "political wilderness," reporting on the biggest cultural story of our day while progressives ignore it or cover it up. Bilek also runs the Substack Jennifer's Newsletter and the blog The 11th Hour, where she explains her focus:

I write at the intersection of humanity, technology, and runaway capitalism. At this intersection stands transgenderism, what I believe is a glamorous ad campaign generated by elites, invested in tech and pharma, to normalize the changing of human biology.

Bilek is doing something that journalists used to do instinctively: following the money. What she has uncovered is a bombshell that reveals the extent to which the transgender phenomenon has been created by super-wealthy LGBT donors who have a dark and sinister agenda. Her journalism supplies the missing pieces needed to complete the picture of how and why the transgender movement so swiftly achieved cultural dominance. Bilek kindly agreed to an interview in which she shared what she has uncovered thus far.

You've done groundbreaking reporting on the extent to which billionaires have been quietly backing the LGBT movement behind the scenes. To what extent are the cultural shifts we've seen in the past few years astroturfed by big donors?

The cultural shifts we see today regarding gender identity are largely influenced by huge capital inflows from governments, philanthropists, corporations, and investment management and accounting firms like Blackrock and Ernst & Young. While some believe that the ideology originated in universities, funding is directed to these institutions to promote the idea of synthetic sex identities as progressive, which students then carry into the world.

To comprehend the motivations of governments, philanthropists, and big business in this ideology, we must examine its implications. Gender ideology deconstructs human reproductive sex legally, linguistically, socially, and is also attacking mostly young people's reproductive organs by sterilizing them. It is marketing disassociation from sexed reality presented as progressive, which is especially confusing to young people in using their naturally rebellious youthfulness as a corporate trap.

Both the money and the ideology come out of the medical-tech sector, which is itself being integrated into culture through a philanthropic structure that has been attached to the LGBT civil rights political apparatus.

The rapid proliferation of this ideology is attributed to tremendous financial pressure and mainstream media censorship of critics, which aligns with the media's ownership by the medical-tech industry. The intertwining of conglomerates like Hearst, Conde' Nast, and Disney with prominent pharma platforms contributes to the pervasive influence of the techno-medical complex in America.

The tech and medical industries thrive, like all industries, in creating and compartmentalizing new products, a trend seen in the LGBT civil rights movement, which was originally a grassroots movement that became corporatized during the AIDS crisis in the '80s. American transsexualism, rooted in the medical establishment, dates to the 1950s, with the medical assault on reproductive organs. The LGBT community transformed into a profitable investment and marketing constituency after the AIDS crisis. The addition of transsexualism, rebranded as 'transgender' for marketing purposes, introduces a new perspective on sexual identities, further normalizing the detachment of humanity from its foundational roots in sexual reproduction.
